Statement	STSTB is concerned with the safety of students who live within walking distance to their zoned school (as defined by school board policy which can be found under STSTB practice STS-ELG- 001 Transportation Eligibility) and must encounter one or more STSTB identified safety hazards along their route to and from school. STSTB shall determine the criteria necessary for the classification of a hazardous route and shall identify them in the transportation software program. STSTB has developed and follows procedures set up to supply transportation for students who are defined as "walkers" that may be eligible for transportation along designated hazardous routes.
